COMPOSITION:

Each 2.5qm vial contains Quinapyramine Sulphate (B.Vet. C)1.5gm Quinapyramine Chloride (B.Vet. C)1gm Pharmaceutical Form:

Powder for Injection

INDICATIONS:

QUINA-CS Injection is Quinapyramine Sulphate mixed with Quinapyramine Chloride active against Trypanosomabrucei, T. Congolenses, T. equinum, T. equiperdum, T. evansi, T. simiae and T. vivax in various species of animal viz. cattle, buffalo, horses, camels, donkey and

CONTRAINDICATIONS:

QUINA-CS is contraindicated in animals previously found to be hypersensitive to the drug. The drug should not be used in young stock because it cause sweating, salivation, polypnoea, tarchycardia and death might occur.

ADVERSE REACTIONS:

Transient salivation, restlessness and muscular tremors may be observed in some weak animals.

TARGET SPECIES:

Cattle, buffalo, horses, camels, donkey and dogs.

DOSAGE & ADMINISTRATION:

Add 15 ml distilled water into the vial; shake well to make suspension for immediate use. Administer by subcutaneous or intramuscular injection. Massage the injection site to disperse the drug and minimize the risk of local reaction. In endemic areas of Surra and Nagana the animals should be injected at intervals of 2 - 3 months as a prophylactic measure

Recommended dose is 2ml per 45kg body weight by SC or IM injection. Divide more than 15ml dose in 2-3 different injection sites.

WITHDRAWAL PERIOD:

Meat: 21 days

Milk: 4 days

STORAGE CONDITIONS AND SHELF LIFE:

Store below 25°C without freezing and refrigerating.

Keep away from sunlight.

Do not store the reconstituted suspension.

SPECIAL WARNINGS FOR EACH TARGET SPECIES:

In horses local reactions to S.C.I. may occur at the sites of injection so the dose must be divided into 2 or 3 injections at different sites or inject I.M.

The prepared suspension for immediate use, and shake well before use.

Estimate live weight carefully and allow animals' access to shade and water after dosing. Message the injection site well.

The dose may be divided into 2 doses with 12 hours intervals.

Estimate live weight carefully and allow animals access to shade and water after dosing.

Do not store the reconstituted suspension.
